The total quoted value, including GST @ 18% comes to Rs.18,09,23,525.37 (Rupees Eighteen-Crore Nine Lakh Twenty-three Thousand Five Hundred Twenty-five and Paise Thirty-seven only).

The annualized value of the contract amount (Excluding GST) is Rs.5,11,08,341/- with a period of contract of 1095 days.
