With reference to above, the Competent Authority has accepted your offered value in %age w.r.t. Estimated Value against NIT-841, Dt. 18.01.2022, for the work of "Hiring of Pay Loaders for Mechanical Transfer of Coal into Railway Wagons at both the Platforms of Y-Curve Siding of Lakhanpur OCP, Lakhanpur Area, MCL", in accordance with detailed NIT provisions. The quantity, amount with other details at a base diesel price of Rs.91.84/Ltr, with applicable CIL wages for a period of 365 (Three Hundred Sixty-five) days are tabulated as under: -

After inclusion of GST @18% in the quoted value, the value comes to Rs.4,72,53,647.52 (Rupees Four Crore Seventy-two Lakh Fifty-three Thousand Six Hundred Forty-seven and Paise Fifty-two) only.

The annualized value of the contract amount (Including GST) is: Rs.4,72,53,648/- (With the period of contract of 365 days)



Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount i.e. Rs.4,72,53,648/-, is Rs.14,17,610/- (Fourteen Lakh Seventeen Thousand Six Hundred Ten Rupees) Only.

**You are advised to deposit Performance Security of Rs.14,17,610/- (Fourteen Lakh Seventeen Thousand Six Hundred Ten Rupees) Only as per Clause No. 4 of General Terms & Conditions mentioned in the Condition of Contract.**

The time of completion for the work shall be 365 days which shall be counted from the expiry of 10(Ten) days from the issue of Letter of Acceptance/ Work Order or handing over site of work, whichever is later.

However, the date of commencement may be decided with mutual consent with the Contractor on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work, prior to the date as prescribed above.

You are advised to contact the General Manager, Lakhanpur Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured by the Area Authority:
