After inclusion of GST @18% in the quoted value, the value comes to Rs.18,13,78,376.78 (Rupees Eighteen Crore Thirteen Lakh Seventy-Eight Thousand Three Hundred Seventy-Six and Paise Seventy-Eight) only.

The contract amount (Including GST) is Rs.18,13,78,376.78, with the period of contract of 180 days.

Therefore, Performance Security (first part of security deposit) is Rs.1,10,33,852/- (Rupees One Crore Ten Lakh Thirty-three Thousand Eight Hundred Fifty-two) Only i.e. 3% of the annualized value of contract amount, which comes to Rs.36,77,95,041.80.

You are advised to deposit Performance Security of Rs.1,10,33,852/- (Rupees One Crore Ten Lakh Thirty-three Thousand Eight Hundred Fifty-two) Only as per Clause No. 4 of General Terms & Conditions of Contract.

The time of completion for the work shall be 180 days, which shall be counted from the expiry of 10 (Ten) days from the issue of Letter of Acceptance/ Work Order or handing over site of work whichever is later.

However, the date of commencement of work may be decided with mutual consent on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work prior to the date as prescribed above.

You are advised to contact the General Manager, Basundhara Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:

Indemnity Bond shall also be furnished by you as per Terms and Conditions of NIT. You have to sign the Integrity Pact as per the format annexed in General Terms & Conditions of the NIT.
