With reference to above, the Competent Authority has accepted your offered value in %age w.r.t. Estimated Value against NIT-856, Dt. 11.09.2022, for the work of "Hiring of pay Loaders for Mechanical transfer of Coal at coal stock yard of Bhubaneswari OCP, Jagannath Area into tippers/trucks of road sale and washery, Bhubaneswari OCP, Jagannath Area, MCL", to execute the quantity in accordance with detailed NIT provisions. The tendered quantity, amount with other details at a base diesel price of Rs. 96.12/Ltr, with applicable CIL wages for a period of 1095 (One Thousand and Ninety-five) days are tabulated as under: -

After inclusion of GST @18% in the quoted value, the value comes to Rs.9,84,96,783.00 (Rupees Nine Crore Eighty-four Lakh Ninety-six Thousand Seven Hundred Eighty-Three) only.

The annualized value of the contract amount (Including GST) is: Rs.3,28,32,261/-, with the period of contract of 1095 days.



Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount i.e. Rs.3,28,32,261/-, is Rs.9,84,968/- (Rupees Nine Lakh Eighty-four Thousand Nine Hundred and Sixty-eight) only.

You are advised to deposit Performance Security of Rs.9,84,968/- (Rupees Nine Lakh Eighty-four Thousand Nine Hundred and Sixty-eight) only as per Clause No. 4 of General Terms & Conditions mentioned in the Condition of Contract.

The time of completion for the work shall be 1095 days which shall be counted from the expiry of 10(Ten) days from the issue of Letter of Acceptance/ Work Order or handing over site of work whichever is later.

However, the date of commencement of work may be decided with mutual consent on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work prior to the date as prescribed above.

You are advised to contact the General Manager, Jagannath Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:

Indemnity Bond shall also be furnished by you as per prescribed format enclosed. You will have to enter into an agreement with Area Authority after submission of requisite documents and observing necessary formalities as per Terms and Conditions, detailed in the NIT, the payment for the work done would be made only after execution of the agreement.

You have to sign the Integrity Pact as per the format annexed in General Terms & Conditions of the NIT.
