After inclusion of GST @18% in the quoted value, the value comes to Rs.7,49,83,147.20 (Rupees Seven Crore Forty-nine Lakh Eighty-three Thousand One Hundred Forty-seven and Paise Twenty) only.

The annualized value of the contract amount (Including GST) is Rs.2,49,94,383/-, with the period of contract of 1095 days.

Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount i.e. Rs.2,49,94,383/-, is Rs.7,49,832/- (Rupees Seven Lakh Forty-nine Thousand Eight Hundred and Thirty-two) Only.

You are advised to deposit Performance Security of Rs.7,49,832/- (Rupees Seven Lakh Forty-nine Thousand Eight Hundred and Thirty-two) Only as per Clause No. 4 of General Terms & Conditions mentioned in the Condition of Contract.

However, the date of commencement of work may be decided with mutual consent on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work prior to the date as prescribed above.

You are advised to contact the General Manager, Lakhanpur Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:

Indemnity Bond shall also be furnished by you as per prescribed format enclosed. You have to sign the Integrity Pact as per the format annexed in General Terms & Conditions of the NIT.
