After inclusion of GST @18% in the quoted value, the value comes to Rs.4,09,67,632.70 (Rupees Four Crore Nine Lakh Sixty-seven Thousand Six Hundred Thirty-two and Paise Seventy) only.

The Contract value for the purpose of deduction of Performance Security would be exclusive of GST.

The annualized value of the Contract amount (Excluding GST) is Rs.1,15,72,778/-, with the period of contract of 1095 days.

Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount i.e. Rs.1,15,72,778/-, is Rs.3,47,184/- (Rupees Three Lakh Forty-seven Thousand One Hundred and eighty-four) Only.
