After inclusion of GST @18% in the quoted value, the value comes to Rs.47,47,72,764.35 (Rupees Forty-seven Crore Forty-seven Lakh Seventy-two Thousand Seven Hundred Sixty-four and Paise Thirty-five) only.

The annualized value of the contract amount (Including GST) is Rs.15,82,57,589/- with the period of contract of 1095 days.

Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount of Rs.15,82,57,589/-, is Rs.47,47,728/- (Rupees Forty-seven Lakh Forty-seven Thousand Seven Hundred and Twenty-eight) Only.

Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:
