After inclusion of GST @18% in the quoted value, the value comes to Rs.7,21,19,181.59 Only (Rupees Seven Crore Twenty-one Lakh Nineteen Thousand One Hundred Eighty-one and Paise Fifty-Nine).

The contract amount (Excluding GST) is Rs.6,11,17,950.50 with the period of contract of 350 days.

Therefore, the Performance Security (first part of security deposit) i.e. 5% of the contract amount of Rs.6,11,17,950.50, is Rs.30,55,898/- Only (Rupees Thirty Lakh Fifty-five Thousand Eight Hundred and Ninety-eight).

You are advised to deposit Performance Security Rs.30,55,898/- Only (Rupees Thirty Lakh Fifty-five Thousand Eight Hundred and Ninety-eight) as per Clause No. 4 of General Terms & Conditions of Contract.

The time of completion for the work shall be 350 days, which shall be counted from the expiry of 10 (Ten) days from the issue of Letter of Acceptance/ Work Order or handing over site of work whichever is later.

However, the date of commencement of work may be decided with mutual consent on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work prior to the date as prescribed above.

You are advised to contact the General Manager, Jagannath Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:


