The total quoted value, including GST @ 18% comes to Rs. 12,15,60,152.96 (Rupees Twelve- Crore Fifteen Lakh Sixty Thousand One Hundred Fifty-two Rupees and Paise Ninety-six only).

The annualized value of the Contract amount (Excluding GST) is Rs.3,43,39,026.26, with the period of contract of 1095 days.

Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 2.1(C) of Eligibility and Experience Criteria is to be ensured:

You have to sign the Integrity Pact as per the format annexed in General Terms & Conditions (GTC)/Service Level Agreement (SLA) of the NIT.

You have to fulfill the applicable provisions of GeM Portal.
