After inclusion of GST @18% in the quoted value, the value comes to Rs.442,67,98,494.86 (Rupees Four Hundred Forty-two Crore Sixty-seven Lakh Ninety-eight Thousand Four Hundred Ninety-four and Paise Eighty-six) Only

The annualized value of the contract amount (Including GST) is Rs.221,33,99,248/-, with the period of contract of 730 days.

Therefore, the Performance Security (first part of security deposit) i.e. 3% of the annualized value of the contract amount i.e. Rs.221,33,99,248/-, is Rs.6,64,01,978/- (Rupees Six Crore Sixty-four Lakh One Thousand Nine Hundred Seventy-eight) Only.

You are advised to deposit Performance Security of Rs.6,64,01,978/- (Rupees Six Crore Sixty-four Lakh One Thousand Nine Hundred Seventy-eight) Only as per Clause No. 4 of General Terms & Conditions of Contract.

The time of completion for the work shall be 730 days which shall be counted from the expiry of 10 (Ten) days from the issue of Letter of Acceptance/ Work Order or handing over site of work, whichever is later.

However, the date of commencement of work may be decided with mutual consent on any date after issuance of Letter of Acceptance/Work Order or handing over the site of work prior to the date as prescribed above.

You are advised to contact the General Manager, Jagannath Area, MCL and start the work as per the Terms & Conditions of NIT. Formal Work Order will be issued by Area Authority. Before commencement of work, submission of updated registration books (R.C. Books) of equipments, mandatory under Motor Vehicle Act against the following Minimum Capacity required for each fleet/equipment as per Clause No. 8.1 (C) of NIT is to be ensured:

You have to sign the Integrity Pact as per the format annexed in General Terms & Conditions of the NIT.
