# Oppn stalls Assembly over law and order, paddy purchase issues

WITH the Opposition BJD and Congress taking an aggressive stance on the deteriorating law and order situation in the state and mismanagement in paddy procurement, the Assembly was drowned in chaos on Friday.

Speaker Surama Padhy had to adjourn the House twice till 4 pm as Opposition members trooped to the well from the beginning of question hour. The question hour was completely washed out and the House could meet only for six minutes in the pre-lunch session.

However, difference cropped up between the BJD and Congress on issues to be discussed in the House. While the BJD members were in the well shouting slogans against the government for the large scale mismanagement in paddy procurement, the Congress wanted discussion on the dismissal of the Speaker.

The House was initially adjourned till 12 pm by the Speaker and when it reassembled, the Congress members remained in their seats as the adjournment motion on law and order brought by them was allowed for discussion by the Speaker.

The BJD members, however, continued to create ruckus seeking discussion on mismanagement in paddy procurement and the prevalence of karni-chhatri at the mandis.

Opposition chief whip Pramila Malik told mediapersons that the BJD members staged an agitation in the House as the Speaker rejected the party's notice for a discussion on farmers' issues. "At least 14 farmers have died by suicide over crop loss due to unseasonal rains. We had given a notice for a discussion on the issue. However, the Speaker refused to accept it.

Farmers are on the streets and have alleged that they are not being paid for about 10 kg of paddy per quintal due to the deduction in the name of karni-chhatri," she said.

Leader of the Congress legislature party Rama Chandra Kadam said though they also wanted discussion on farmers' issues, the party prioritised the law and order situation on the day.

BJP member Irishach Acharya blamed both the BJD and the Congress for the ruckus in the House. "The Opposition has no issue. They just want to keep the House paralysed. The people are watching their activities," he said.

"Our government is committed to making women self-reliant and building a prosperous Odisha. The women community support staff play a crucial role in this vision. To address their challenges, we have taken an important step by

launching this scheme," he said.

Majhi said the Odisha Livelihood Mission is functioning under the National Livelihood Mission since April 1, 2012. Under the scheme, rural self-help groups (SHGs) are formed to provide livelihood opportunities to the womenfolk. The community support staff were appointed to strengthen and empower SHGs, cluster-level federations (CLFs) and GPLFs.

Stating that the GPLFs could not become self-sufficient because of lack will power of the previous government, the

chief minister said as a result the CSS were not paid on time.

The CSS get remuneration of ₹6,500 to ₹10,500 as per their work. They also received travel and telephone allowance of ₹350 and ₹250 respectively.

Majhi said the state government is implementing the Lakhpati Didi Yojana for the economic growth of women in SHGs. The goal is to help as many women SHG members as possible to earn an income of ₹1 lakh annually. A target has been fixed to create 25 lakh lakhpati didis by 2027. The support staff will now function to achieve the target.

# GUV PUSHES FOR LISTING STATE PSUs IN STOCK MARKET

GOVERNOR Hari Babu Kambhampati on Friday proposed listing of select state public sector undertakings (PSUs) in the stock market.

Making the proposal at a review meeting of the performance of PSUs at Raj Bhawan here, Kambhampati said this initiative will enhance accountability, drive performance and increase the financial strength of Odisha's PSUs.

Kambhampati said the core responsibility of PSUs is to ensure transparency, efficiency and financial discipline in managing public resources. "A well-functioning PSU not only enhances the company's value but also contributes significantly to the state's wealth," he said.

However, expressed concern over the failure of several PSUs to conduct annual general meetings (AGMs) or finalise their annual ac-

counts, terming it as a violation of corporate governance principles. He urged PSU heads to adhere strictly to financial norms, hold AGMs regularly, and finalise accounts by September 30 of the following financial year.

He also stressed the need for timely audits and regular submission of audit reports to build credibility and respectability with the public.

Drawing inspiration from Gujarat's success under the leadership of Prime Minister Narendra Modi, the Governor cited how devalued PSU stocks there have now become highly sought-after investments.

"PSUs are the backbone of our economy. Their full potential must be realised for the benefit of the people and the state," he emphasised.
