

UK min resigns over Starmer's foreign aid cut

London: The British minister responsible for international development quit Friday in the wake of Prime Minister Keir Starmer's decision earlier this week to ramp up defense spending by slashing the foreign aid budget. In a letter to Starmer, Anneliese Dodds resigned as international development minister and minister for women, saying there were 'no easy paths' to increasing defence spending but that she disagreed with the decision to cut overseas aid, which she warned would only lead to China and Russia filling the vacuum.
