Re-produced below, the observations received from Chief Vigilance Officer, MCL which are self-explanatory:-

"During inspection of a project by a Vigilance team, MBs of the particular works were asked from the Civil Engineers to verify the execution of the work. But, Civil Engineers could not provide the MBc saying that MBs were lying in account section of the department. Later on after further verification

- Particular 139s were not in the possession of account section. However, Civil Engineers themselves located the MBs lying somewhere in the office.
- In that particular project all the measurement books as per record are not physically (ii)available in the stock and in MB movement register it is not mentioned to whom the missing M8s are issued.
- (iii) In this particular project MBs issued in the name of one Supervisor are taken by another Supervisor for recording measurements. Whereas MBs are issued by the Engineer-incharge in the name of particular Supervisor) Overseer / Sr. Overseer/ Engineer Assistant) for recording measurement of the works supervised by him. Also , the old MBs which should have been kept in safe custody are taken by a Supervisor directly from the stock and without authentication by the EIC. These are highly irregular which increase the probability of loss of the MBs of completed works as well as tempering of the old

.To avoid the above irregularities and to streamline the maintenance of MB, circular needs to be issued on the following:-

- 1. All projects should ensure that MBs are kept is safe custody and MB movement register is maintained properly. In this regard confirmation from all projects be obtained that all the MBs are readily available with them in the stock and the MBs which are not in stock are available with the concerned supervisors to whom they are issued. This ey should be confirmed so as to enable future verification. b
- MBs chould be made available on demand by any investigating agency/ audit etc.
- 3. For important and high valued works separate MB be used and after completion of the work the same be deposited in the stock
