At the out set, Sub Collector, Talcher welcomed all the members present in the meeting.

In the meeting dtd.18.12.2013, it was decided to consider date of 11(1) order relating to Konark Block i.e 26.09.2009 as cutoff date. However four years have lapsed in the mean time and no award has been passed so far. The Sub Collector, Talcher expressed his displeasure on the delay.

- (3) A database / pre-sponsorship list shall be complied by 15th March-2014 considering 11(1) order under CBA (A&D) Act of Konark Block as the cut off date and shall be kept open for the villagers for necessary verification and modification, if any, upto 31st March-2014.

After having discussed at length on the issue of valuation, the villagers agreed to the basis of 2004 SOR as suggested by the R&B. However, the villagers led by Sri Muralidhar Sahoo stated that some of them had used kiln burn bricks in construction of houses whereas valuation by MCL is always done treating the same to be CB bricks.

It was decided that the owners of the houses made up of kiln bricks will submit their application in an week's time and the samples drawn from their houses will be carried to any authorized Govt. Laboratory or IGIT, Sarang at the cost of MCL. In the event the bricks test positive, valuation will be done accordingly.


- 6) A meeting of the representatives of Solada villagers will be held with the General Manager, Hingula Area in the 1st week of November-13 to discuss the progress of the job.
