NOTICE

Sub: Expression of Interest (EoI) for procurement of washed non-coking coal from IB Valley washery of MCL

Expression of Interest is sought from all the linked Power Houses having FSA/ MoU with MCL, to procure washed non coking coal from IB Valley Washery located at Lakhanpur Area with expected washed coal production of 7.87 MTPA.

The washed coal expected to be produced shall be with ash content of 33.5% with variation of 0.5% i.e. the ash content shall be between 33% to 34%. The basic price of washed non-coking coal shall be Rs. 2260 per tes for Power sector. In addition to the basic price, STC (as applicable for Surface Transportation charges of the washed coal), GST, GST compensation Cess shall be applicable for supply of washed non-coking coal. The basic price is subject to revision as and when there is any revision of any component of washed coal pricing i.e. price of raw coal, STC and/or levies & taxes including new levies & taxes imposed by Government or statutory bodies time to time or at the sole discretion of MCL. The provisions related to bonus/penalty for increase or decrease in ash content above 34% and below 33% shall remain same as mentioned in the earlier notice no MCL/SBP/GM(M&S)/Secy/2022-23/1213 Dt 03.02.2023. The lifting of washed coal can be done through both rail or road mode. One siding, namely BOCM-6 (BOMB) of Lakhanpur area has been tentatively earmarked for dispatch of washed coal by Rail.

MCL has already executed MoU with MAHAGENCO & APGENCO based on the interest submitted against earlier EoI. All other interested and eligible Power Houses are requested to submit their interests by 17.05.2024 in the attached format for consideration and execution of non-binding MoU.
